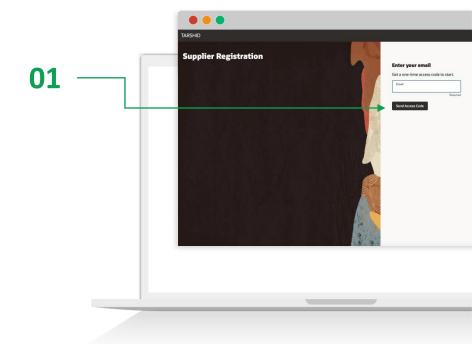

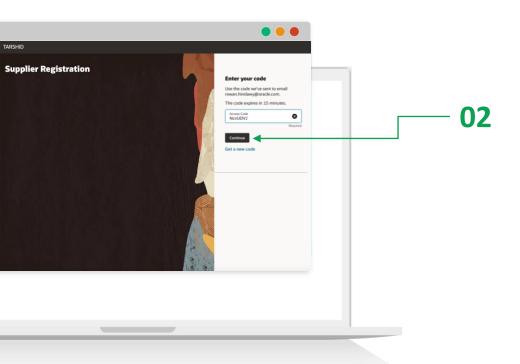

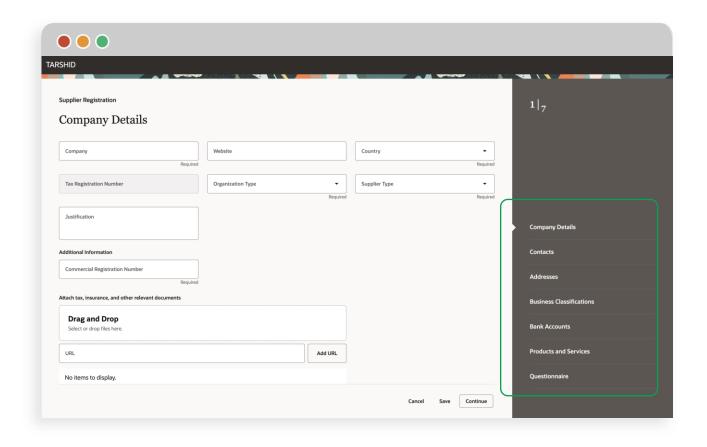
- 1. Enter your organization's official email address to receive an access code for the supplier registration form.

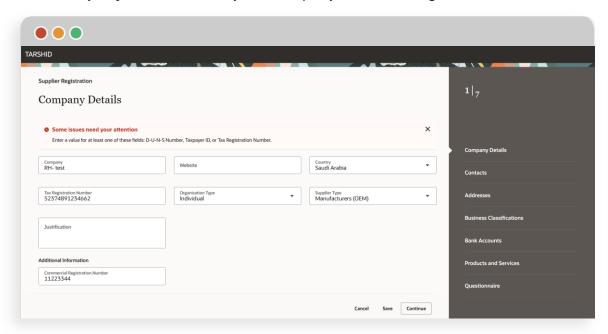

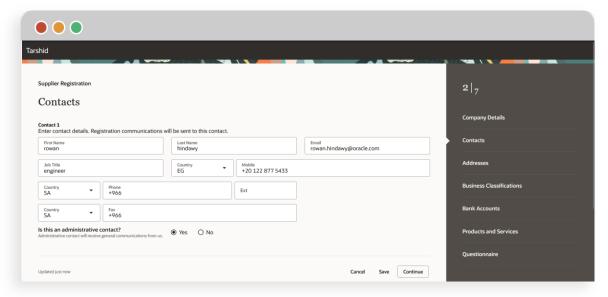

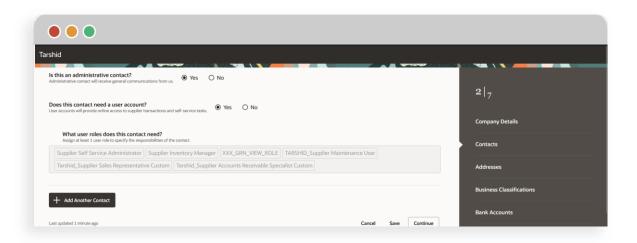
1. Company Details: Enter your Company details in English

- 2. Contact: Add only Authorized contact with official email address.



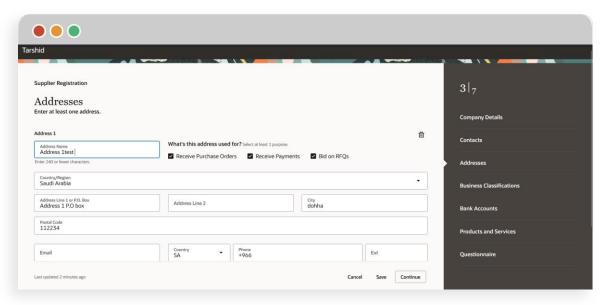




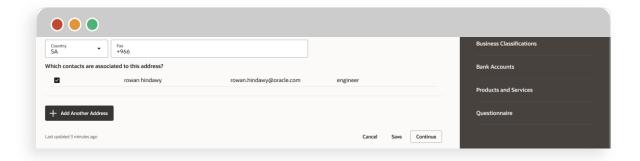
- *Add only contact that you will include in the Letter of authorization.

3. Address: Enter your company address details and link it to the added Contact.

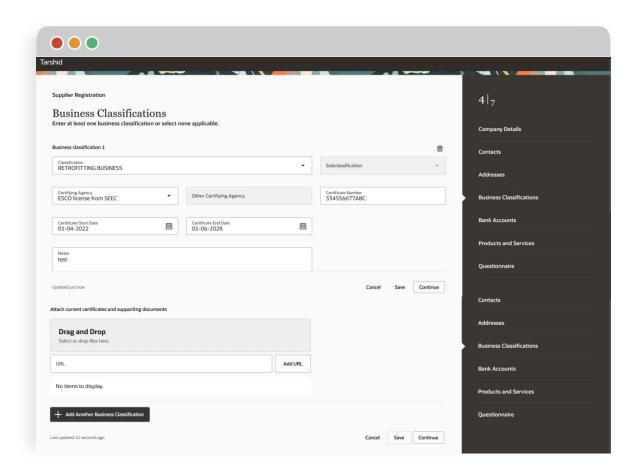


To associate the contact to the address, click on the below icon > highlight the contact > save > Continue

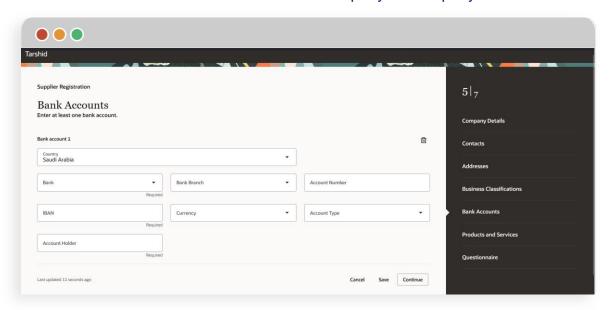

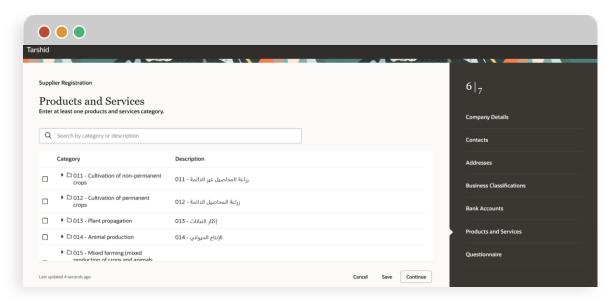

5. Bank Accounts: Enter the bank details as per your company official Bank letter.



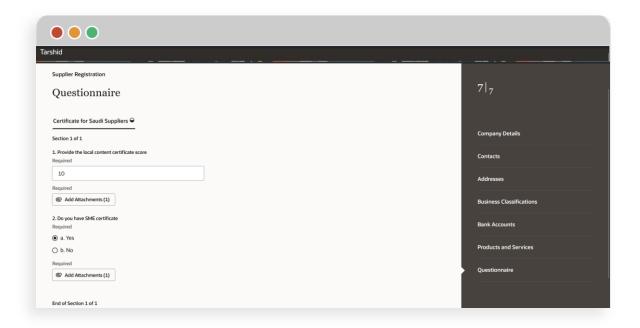

- 6. Products & Services: Select sub-category as per your company core business.

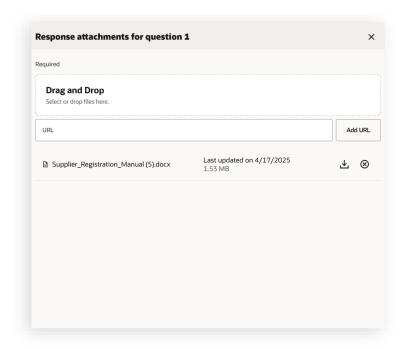

- *(Selected category must match your company activities and core business "Goods\Services you provide").



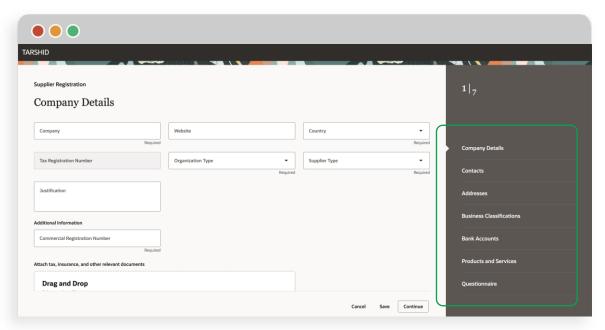
- **7. Questionnaire:** Suppliers are required to provide answers to page 7 sections.
- > All suppliers type (ESCO and non-ESCO) should provide the answers to the questions appear in the questionnaire page sections.



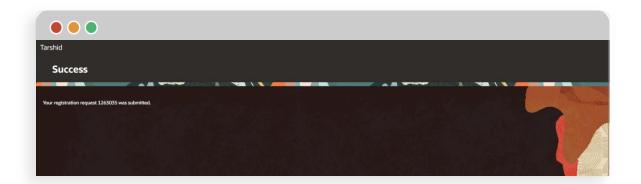




8. Review and Register: Review your Registration then Submit it.
